# 6. As a City Councilperson, what would be your priorities for the 132<sup>nd</sup> District and for Bridgeport as a whole?

### Several issues stand out as ones I hope to focus on as a member of City Council:

1. **Education:** To support our Bridgeport City Schools through increased educational funding from both the City of Bridgeport, as well as the Education Cost Share (ECS) formula; and to advocate for the forthcoming state legislation to increase ECS funds for Bridgeport Schools.

2. **Economic Development**: To support growing the tax base by developing city owner properties; to seek funding for remediation of brownfields; and to pursue supermarket companies to invest their stores in Bridgeport neighborhoods.

3. **Quality of Life:** To improve the quality of life in our neighborhoods by increasing efforts to address blight and illegal dumping; to increase funding for street paving; and to promote the 50/50 sidewalk program for homeowners.

4. **Lowering Taxes**: To work with our state delegation to secure more PILOT funding and increase the tax base in order to reduce property taxes, thereby easing the burden on current homeowners in the City, and attracting new homeowners.

5. **City Charter:** To support the formation of a commission to begin the process of updating our City's Charter.
